Dear Mr. Skagen,

Thank you for your telephone conversation last Tuesday, 1 August, 2000. We appreciate your frankness, and understand your concerns. Please allow me to take the opportunity to respond to several of your concerns and statements.

Firstly, IMS certainly understands that Nucor, Hertford feels as though it has been "abandoned" and "that little consideration was given to Nucor" before it ended the distributorship agreement with IMS Measuring Systems Inc. Nothing could be further from the facts. According to IMS GmbH (our parent company), Nucor, Hertford was the single most discussed customer pending this decision. It is understood that Nucor, Hertford, as with many IMS customers, does not know all of the facts. Of course, IMS is not at liberty to discuss these facts at this time, but felt strongly that there was more than sufficient reason to end the relationship when it did. The actions by the previous distributor of IMS GmbH made no other decision possible.

When IMS Systems Inc. was created as a wholly owned subsidiary of IMS GmbH, the very first order of business was to travel to the State of Georgia, and the Nuclear Regulatory Commission. All authorities were receptive to our requests to expedite amendment to the Federally approved device registrations and our application for license to service and distribute our equipment. IMS can state categorically that at this time, the device registrations at NRC, Washington D.C. are being amended. We received information from NRC Washington today that the review of the device registrations will be completed by the end of this week. The device registration number NR-375-D-102-S has been expedited for the amendment adding IMS Systems Inc. as a licensed distributor. Our license to service and distribute these devices is under review at NRC Region 1. At the moment, Region 1 is waiting for the device registration amendment from Washington D.C. Therefore, based upon all available information from the NRC, IMS has confidence that all required licensing will be completed in time to have the sources on site in a timely fashion.

Secondly, neither IMS GmbH nor any of its subsidiaries will enter into any agreement of any type with IMS Measuring Systems Inc. related to any facet of this project. We will not debate the validity of the IMS Measuring Systems Inc. proposal.

Finally, on behalf of IMS GmbH and IMS Systems Inc., I personally apologize for the position in which Nucor has been placed and any inconvenience that Nucor may have encountered to date. I recognize that this apology is of little consolation, but merely wish to assure you that IMS GmbH and IMS Systems Inc. are doing all that is possible to improve the situation of delivery, installation supervision, and start-up.

In the meantime, could you please forward to IMS Systems Inc. a copy of the site license from the State of North Carolina for the possession of our 5245 device (NRC device registration number NR-375-D-102-S)? With this in hand, we will be one step closer when our service and distribution license is issued.
