This letter confirms the telephone conversation between Mr. E. Viglucci, of the Tennessee Valley Authority (TVA) , and Mrs. Anne Boland of this office on August 7, 2001, concerning a Predecisional Enforcement Conference with you, which has been scheduled for August 27, 2001, at 8:00 a.m. The purpose of the meeting is to discuss an apparent violation of 10 CFR 50.5, Deliberate Misconduct, associated with an April 30, 2001, Department of Labor Final Decision and Order finding that TVA discriminated against a Watts Bar employee in violation of Section 211 of the Energy Reorganization Act. The location of the conference will be at the Region II Office, Sam Nunn Atlanta Federal Center, 61 Forsyth Street, S.W., Atlanta, Georgia, in Executive Conference Room 24T65. The meeting will be transcribed and a closed meeting in accordance with Section V of "The General Statement of Policy and Procedures for NRC Enforcement Action - May 1, 2000, NUREG-1600 (Enforcement Policy), in that enforcement action is being considered against an individual.
