

SUMMARY OF FITNESS FOR DUTY PROGRAM ACTIVITIES FOR JANUARY THROUGH JUNE 2001

POSITIVE RESULTS:

One positive result attributed to alcohol.

PRE-ACCESS:

There were no positive results to report during this period.

RANDOM:

There were no positive results to report during this period.

FOR-CAUSE/BEHAVIOR:

One for-cause test performed on a licensee employee during this period resulted in a confirmed positive for alcohol.

- Co-workers reported to their supervisor an employee smelling of alcohol. The supervisor requested a for-cause test of the employee and the result was a confirmed positive for alcohol. The employee was denied unescorted access in accordance with Cooper Nuclear Station Procedure 0-FFD-01. Upon completion of actions required in 0-FFD-01, the employee was placed in the follow-up testing program and unescorted access was reinstated.

FOR-CAUSE/POST ACCIDENT:

No for-cause/post accident tests were recorded during this period.

RANDOM TESTING RATE:

The random testing rate for this period was 52.6%.
