Discussion Topic:

Request for exemption from 10 CFR 71.5(b) for noncommercial transportation of military commodities incorporating limited quantities of licensed radioactive material.

Example of Shipment Categories that the exemption would cover:

- ◆ DOT Instruments and Articles - sealed sources
- ◆ DOT Limited Quantities - sealed sources

Exemption applicable under the following conditions:

- ◆ When deployed during a conflict.
- ◆ During convoy operations.
- ◆ During transportation on Federal property.
- ◆ During transportation by DoD personnel in DoD operated vehicles during the performance of DoD operations/mission.
