<u>Brief description of amendments</u>: The amendments change surveillance requirements in Technical Specifications (TSs) 3/4.7.6, 3/4.7.7, 3/4.9.12, and associated TS Bases, to revise the minimum heater capacity, and the relative humidity testing requirements for the control room emergency filtration system (CREFS), the piping penetration area filtration and exhaust systems (PPAFES), and the fuel handling building post accident

filter system (FHBPAFS).


