The Commission is being asked to act on a Memorandum and Order responding to two petitions to intervene and requests for a hearing, submitted by the Citizens Awareness Network and the Town of Cortlandt, New York, together with the Hendrick Hudson School District, related to the proceeding for the Indian Point 1 and Indian Point 2 license transfers. The Commission has voted to approve a Memorandum and Order which grants standing to the petitioners, admits certain issues regarding financial qualifications, and grants a hearing under Subpart M, and rules on motions. Would you please affirm your votes?
