SUMMARY OF MANAGEMENT ACTIONS

Lessons Learned and Actions Taken

Integration

In December 2000, Carolina Power & Light Company (CP&L) and Florida Power Corporation (FPC) became subsidiaries of Progress Energy. Carolina Power & Light's nuclear plants include Brunswick, Harris, and Robinson. Florida Power Corporation operates the Crystal River Nuclear Plant. This report contains Fitness For Duty (FFD) Program data for each of the plants listed above from CP&L and from FPC.

Health & Human Services (HHS) Certified Laboratory Issue

Corporate FFD notified the four nuclear plant sites on 6/8/2001 that the primary HHS certified laboratory had notified Corporate FFD that a split specimen could not be located to send to the secondary HHS certified laboratory for testing as requested. The split specimen in question was a blind quality control specimen that had been chosen to send to the secondary HHS certified laboratory. The Security organizations at the Brunswick, Crystal River, Harris, and Robinson Plants each made a Safeguards Event Log entry. A significant action report was initiated, and a root cause evaluation was performed. The evaluation determined that an HHS certified laboratory employee had missed a procedure step which required Bottle A and Bottle B to be kept together in the same location. Bottle A was placed in a box designed for non-negative specimens. It was concluded that Bottle B remained in the negative hometray and was destroyed with other negative specimens. The HHS certified laboratory initiated a corrective action to modify their computer system to require Bottle B to be scanned into the computer with Bottle A at the time that bottle matching is performed. This corrective action will ensure that Bottle B will remain together until final disposition.

EFFECTIVENESS EVALUATION

Fitness For Duty Program Performance Data

Random testing is required to be performed at an annual rate of at least 50% of the workforce in accordance with 10 CFR 26.24(a)(2). The current six month reporting period random testing rate was approximately 27.9% for Carolina Power & Light (CP&L) Plants (Brunswick, Harris, and Robinson) and 26.8% for Florida Power Corporation (FPC) Crystal River Plant. For CP&L, there were 853 random tests conducted with an average of 3050 workers eligible for testing. For FPC, there were 236 random tests conducted with an average of 880 workers eligible for testing.

The total rate of positive test results for this reporting period for CP&L was approximately 1.05%. There were 21 positive results out of 2002 tests. The positive test results were comprised of 20 pre-access, 1 random, 0 for-cause, and 0 other. Unescorted access for the individuals with confirmed positive tests was denied or revoked, as applicable. The total rate of positive test results for this reporting period for FPC was 0%. There were 0 positive results out of 324 tests.

For this reporting period for CP&L, the positive test rate for employees was 0%, with 0 positive results out of 708 tests. For FPC, the positive test rate for employees was 0% with 0 positive results out of 227 tests.

For this reporting period for CP&L, the positive test rate for contractors was approximately 1.62% with 21 positive results out of 1294 tests. For FPC, the positive test rate was 0% with 0 positive tests out of 97 tests.

There were no identified abuses of over-the-counter or prescription medication during the reporting period.

There were no unsatisfactory blind performance tests during the reporting period.
