The Biological Assessment examined the potential impacts associated with the continued operation of Oyster Creek on sea turtle species protected under the Act, supported the renewal of the Incidental Intake Statement (ITS) issued on September 21, 1995, and was part of the formal consultation process provided under Section 7 and defined in Title 50 of the *Code of Federal Regulations* Section 402.

By letter dated July 18, 2001, NMFS issued a Biological Opinion (enclosure 1) which contains an ITS specifying terms and conditions that must be met, as well as reasonable and prudent measures to minimize impacts of incidental take of endangered and threatened sea turtles. The ITS authorizes the annual take of five loggerhead (no more than two lethal), four Kemp's ridley (no more than three lethal), or two green (no more than one lethal) sea turtles. When these annual incidental take limits are reached or exceeded, formal consultation must be reinitiated. By letter dated August 29, 2001 (enclosure 2), NMFS clarified certain aspects of the terms and conditions necessary for compliance.
