**Medical Review Officer (MRO) Six Month Report**

From January 1, 2001, through June 30, 2001, our records indicate the following results:

In the Pre-Access program category, for short-term contractor personnel, three (3) confirmed positives for single substance were experienced. There were no confirmed positives in the Random, For Cause-Observed Behavior and Follow-up program categories. There were no confirmed positives in the licensee or long-term contractor pools.

**Pre-Access Program**

In the Pre-Access program category, short-term contractor personnel pool, three (3) confirmed positives for a single substance were experienced. Each individual participated in separate face-to-face interviews with the Medical Review Officer and was provided the opportunity for split sample testing. The Medical Review Officer adjudicated all three (3) individuals as confirmed positive and unescorted access was denied.

**List of Events Reported**

During the period of January 1, 2001 through June 30, 2001, no events were reported under the provisions of 10 CFR 26.73 by the Beaver Valley Power Station (BVPS).
