SUBJECT: ASSESSMENT FOLLOW-UP - JOSEPH M. FARLEY NUCLEAR PLANT

Dear Mr. Morey:

On August 17, 2001, the NRC staff forwarded a letter concerning the final significance determination of a White inspection finding in the Physical Protection cornerstone at your Farley Nuclear Plant. This finding involved the failure of your protective strategy to prevent mock adversaries from gaining access to certain target sets during force-on-force exercises conducted in July 2000 as part of the NRC's Operational Safeguards Response Evaluation (OSRE).

Therefore, we plan to conduct supplemental Inspection Procedure 95001 during November 2001 to better understand the causes contributing to this finding. This inspection procedure is conducted to provide assurance that the root causes and contributing causes of risk significant performance issues are understood, the extent of condition is identified, and the identified corrective actions are sufficient to prevent recurrence. The scope of this supplemental inspection will depend on the outcome of the OSRE scheduled for the week of September 17, 2001.
