The Commission has issued the enclosed Amendment Nos. 63 and 63 to Facility Operating License Nos. DPR-32 and DPR-37 for the Surry Power Station, Unit Nos. 1 and 2, in response to your submittal of September 19, 1980.

The amendments modify License Nos. DPR-32 and DPR-37 to include a requirement to follow a guard training and qualification plan in accordance with 10 CFR 73.55(b)(4) within 60 days of this approval by the Commission.

We have completed our review and evaluation of the Surry Power Station Nuclear Security Personnel Training and Qualifications Program and have concluded that the plan for your facility, when fully implemented, will provide the protection needed to meet the general performance requirements of 10 CFR 50.54(p) and the objectives of the specific requirements of 10 CFR 73.55(b)(4) and Appendix B to 10 CFR 73. Me, therefore, further conclude that your Nuclear Security Personnel Training and Qualifications Program is acceptable.

Changes which would not decrease the effectiveness of your approved Nuclear Security Personnel Training and Qualifications Program may be made without approval by the Commission pursuant to the authority of 10 CFR 50.54(p). A report containing a description of each change shall be furnished to the Director, Office of Nuclear Reactor Regulation, U. S. Nuclear Regulatory Commission, Mashington, D. C. 20555, with a copy to the appropriate NRC Regional Office within two months after the change is made. Records of changes made without Commission approval shall be maintained for a period of two years from the date of the change.

These amendments apply to the Nuclear Security Personnel Training and Qualifications Program and therefore do not authorize a change in effluent types or total amounts nor an increase in power level, and will

not result in any significant environmental impact. Having made this determination, we have further concluded that these amendments involve an action which is insignificant from the standpoint of environmental impact and pursuant to 10 CFR 51.5(d)(4) that an environmental impact statement, or negative declaration and environmental impact appraisal need not be prepared in connection with the issuance of these amendments.

Since these amendments apply to the Nuclear Security Personnel Training and Qualifications Program, they do not involve significant new safety information of a type not considered by a previous Commission safety review of the facility. They do not involve a significant decrease in the probability or consequences of an accident, do not involve a significant decrease in a safety margin, and therefore do not involve a significant hazards consideration. We have also concluded that there is reasonable assurance that the health and safety of the public will not be endangered by this action and that the issuance of these amendments will not be inimical to the common defense and security or to the health and safety of the public.

We will continue to withhold your Nuclear Security Personnel Training and Qualifications Program and related materials from public disclosure in accordance with the provisions of 10 CFR 2.790(d).

- 1. The Nuclear Regulatory Commission (the Commission) has found that:
 - A. The filing by Virginia Electric and Power Company (the licensee) dated September 19, 1980, complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act) and the Commission's rules and regulations set forth in 10 CFR Chapter I;
 - B. The facility will operate in conformity with the filing, the provisions of the Act, and the rules and regulations of the Commission;
 - C. There is reasonable assurance (i) that the activities authorized by this amendment can be conducted without endangering the health and safety of the public, and (ii) that such activities will be conducted in compliance with the Commission's regulations;
 - D. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public; and
 - E. The issuance of this amendment is in accordance with 10 CFR Part 51 of the Commission's regulations and all applicable requirements have been satisfied.

- 2. Accordingly, Facility Operating License No. DPR-32 is hereby amended by adding a new paragraph 3.K to read as follows:
 - 3.K The licensee shall fully implement and maintain in effect all provisions of the Commission-approved Nuclear Security Personnel Training and Qualifications Program, including amendments and changes made pursuant to 10 CFR 50.54(p). The approved Nuclear Security Personnel Training and Qualifications Program consists of a document withheld from public disclosure pursuant to 10 CFR 2.790(d) identified as "Surry Power Station Nuclear Security Personnel Training and Qualifications Program" dated September 15, 1980. The Nuclear Security Personnel Training and Qualifications Program shall be fully implemented in accordance with 10 CFR 73.55 (b)(4), within 60 days of this approval by the Commission. All security personnel shall be qualified within two years of this approval.
- 3. This license amendment is effective as of the date of its issuance.

The U. S. Nuclear Regulatory Commission (the Commission) has issued Amendment No. 63 to Facility Operating License No. DPR-32 and Amendment No. 63 to Facility Operating License No. DPR-37 issued to Virginia Electric and Power Company (the licensee), which revised the licenses for operation of the Surry Power Station, Unit Nos. 1 and 2, respectively, (the facilities), located in Surry County, Virginia. The amendments are effective as of the date of issuance.

The amendments add license conditions to include the Commissionapproved Nuclear Security Personnel Training and Qualifications Program as part of the licenses.

The licensee's filing complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations. The Commission has made appropriate findings as required by the Act and the Commission's rules and regulations in 10 CFR Chapter I, which are set forth in the license amendments. Prior public notice of these amendments was not required since these amendments do not involve a significant hazards consideration.
