Upon consideration of (1) the August 31, 2001 notice of intervenor Ohngo Gaudadeh Devia (OGD) that it is withdrawing its request for confidential treatment of the exhibits that accompanied the declaration of Sammy Blackbear in support of OGD's June 28, 2001 response to the May 25, 2001 motion of applicant Private Fuel Storage, L.L.C., (PFS) for summary disposition of contention OGD O, Environmental Justice Issues Are Not Addressed; and (2) the August 31, 2001 letter of intervenor Skull Valley Band of Goshute Indians (Skull Valley Band) indicating it is considering filing a motion for protective order regarding these exhibits in the near future, it is
