#### Gentlemen:

The purpose of this letter is to provide additional information to the NRC Staff following their review of References 1 and 2 above. In the Application submitted with Reference 1, TXU Electric Company ("TXU Electric") requested, pursuant to Section 184 of the Atomic Energy Act of 1954, as amended ("Act"), and 10 CFR § 50.80, that the Nuclear Regulatory Commission ("NRC") consent to the direct transfer of control of TXU Electric's operating authority and 100% ownership interest in the Comanche Peak Steam Electric Station, Units 1 and 2 ("CPSES") on January 1, 2002, to a Texas limited partnership, TXU Genco, TLP. TXU Electric also requested that the NRC issue the required conforming administrative amendments to the CPSES licenses. Reference 2 described a revision to the Application and a revision to the financial statements submitted with the Application.

Terry which requests, on behalf of TXU Electric, that the additional information being provided herein for CPSES in Enclosure 4 be withheld from public disclosure pursuant to 10 CFR § 2.790 because Enclosure 4 contains confidential commercial or financial information which is considered proprietary.

Enclosure 3 provides a non-proprietary version of the additional financial information being provided herein for CPSES in Enclosure 4.

Enclosure 4 provides the additional financial information requested by the NRC Staff for CPSES. This enclosure contains confidential commercial or financial information which is considered proprietary.

The Application, as revised by Reference 2, is otherwise unchanged by this submittal. The original "Safety Analysis" (Attachment 1 of the Application) which includes the "No Significant Hazards" evaluation remains valid.

#### **AFFIDAVIT OF C. L. TERRY**

- I, C. L. Terry, Senior Vice President & Principal Nuclear Officer at TXU Electric Company ("TXU Electric"), do hereby affirm and state:
- 1. I am authorized to execute this affidavit on behalf of TXU Electric.
- 2. TXU Electric is providing information in support of its Application for Order Consenting to License Transfers and Approving Conforming Administrative License Amendments. The documents being provided in Enclosure 4 contain business plans and financial projections related to the ownership and operation of a TXU Electric generating asset, the Comanche Peak Steam Electric Station, Units 1 and 2 ("CPSES"). These documents constitute proprietary commercial and financial information that should be held in confidence by the NRC pursuant to the policy reflected in 10 CFR §§ 2.790(a)(4) and 9.17(a)(4), because:
  - I. This information is and has been held in confidence by TXU Electric.
  - ii. This information is of a type that is held in confidence by TXU Electric and there is a rational basis for doing so because the information contains sensitive financial information concerning the projected revenues and operating expenses of TXU Electric and its successors and affiliates.
  - iii. This information is being transmitted to the NRC in confidence.
  - iv. This information is not available in public sources and could not be gathered readily from other publicly available information.
  - v. Public disclosure of this information would create substantial harm to the competitive position of TXU Electric and its successors and affiliates by disclosing their internal financial projects.
- 3. Accordingly, TXU Electric requests that the designated documents be withheld from public disclosure pursuant to the policy reflected in 10 CFR §§ 2.790(a)(4) and 9.17(a)(4).
