ORDER

On November 8, 2001, at 8:30 a.m. in the Atomic Safety and Licensing Board Panel's hearing room, third floor, Two White Flint North, 11545 Rockville Pike, Rockville, Maryland, the Presiding Officer and the two special assistants in this proceeding, Judge Murphy and Judge Brett, will hold a hearing session pursuant to 10 C.F.R. § 2.1235. At that session, the Judges will question the parties' expert witnesses and ask questions of the parties' counsel concerning the Applicant's Restoration Action Plan for Church Rock Section 8 and the Intervenors' challenges to it. No later than November 1, 2001, any party may propose written questions to the Presiding Officer that it wishes asked of an opposing party's expert witness. Such questions need not be served on the other parties to the proceeding. Although the Presiding Officer anticipates that the questioning of witnesses and counsel will take far less than a full day, the parties nonetheless should plan on a full day in the event the settlement judge may wish to meet with the parties at the conclusion of the hearing session.

As was made clear during the August 29, 2001, telephone conference, the previously scheduled September 12, 2001, telephone conference is canceled.
