SUBJECT: CONCURRENCE ON DRAFT REGULATORY GUIDE DG-1085 AND
DRAFT NUREG-1713 REGARDING DECOMMISSIONING COST
ESTIMATES (TAC NOs.: MA9307 AND MA9306)

I am responding to your memorandum to Martin Virglio, Director, Office of Nuclear Material Safety and Safeguards, dated August 27, 2001. We have reviewed Draft Regulatory Guide DG-1085, "Standard Content and Format of Decommissioning Cost Estimates for Nuclear Power Reactors," and Draft NUREG-1713, "Standard Review Plan on Decommissioning Cost Estimates for Nuclear Power Reactors." We suggest the following two changes be made:

- Clarify the extent, if any, to which the new guidance supercedes the guidance of Regulatory Guide 1.159, "Assuring the Availability of Funds for Decommissioning Nuclear Reactors." This should be stated in the Introduction sections of the documents.
- Change the primary responsibility for reviewing the updated cost estimate presented in the License Termination Plan (LTP) from NRR to NMSS. This change would align the new guidance with current agency practice.

Assuming the comments above will be incorporated into the guidance documents, we concur with the guidance.
