Notice is hereby given that the Nuclear Decommissioning Financing Committee ("NDFC"), established pursuant to RSA 162-F:15, shall, in accordance with the provisions of RSA 162-F, and RSA 541-A, et seq., hold a public hearing on October 18, 2001 at 7:00 P.M. at the Seabrook Town Offices. The purpose of the hearing will be to receive the views of the public on the Preliminary Report and Order of the NDFC, which establishes a new standard for determining the cost of decommissioning Seabrook Nuclear Power Station, details the level of funding of the Nuclear Decommissioning Fund for the Seabrook Nuclear Power Station as of January 1, 2002, and otherwise implements amendments made to RSA 162-F by the New Hampshire Legislature.

The Preliminary Report and Order of the NDFC, the transcripts of hearings and the record of the docket upon which the NDFC based its determinations are available for public review in the Seabrook Town Clerk's office, starting on September 7, 2001.

A copy of this notice shall be published at least twice in a newspaper having general circulation in that portion of the State in which operations are conducted and a newspaper having state-wide circulation, the last such publication to be not later than October 1, 2001, and a copy of this notice shall be posted in at least two places in the Town of Seabrook, New Hampshire.
