ORDER

At 9:00 a.m. on Friday, September 21, 2001, the Licensing Board will hold a prehearing conference in Room A1 of the North Augusta Community Center, 495 Brookside Avenue, North Augusta, South Carolina, to hear oral arguments on the standing of the Petitioners to intervene in this proceeding and on the admissibility of the Petitioners' proffered contentions. All Participants are free to use less than the various allocations of time set out below. The Petitioners should assume that the Board has carefully read all the pleadings. The Petitioners should focus their oral presentations on the arguments asserted by the Applicant and the Staff in their respective submissions opposing the contentions, and on how their contentions meet the standards of 10 C.F.R. § 2.714(b)(2).

GANE's argument should only address the written responses of the Applicant and the Staff. The time allocations for this argument are as follows:

GANE 15 minutes total. Applicant 10 minutes in response. Staff 5 minutes in response.

Due to the number of contentions and the time constraints for argument, the Board emphasizes that the Petitioners' arguments must focus on the responses of the Applicant and Staff opposing their contentions, and how their contentions meet section 2.714(b)(2). Any deviation from this instruction will be held in extreme disfavor by the Board.
