On April 15, 1998, Sheri Minnick of this office conducted a safety inspection at the above address of activities authorized by the above listed NRC license. The inspection was limited to a review of loss of three exit signs containing tritium (H-3). The findings of the inspection were discussed with Gregory P. Roberts, Chief Executive Officer, Marlboro Psychiatric Hospital at the conclusion of the inspection. In our April 23, 1998 letter to Mr. Roberts we indicated that the NRC may have further questions or concerns related to this event and therefore, considered Inspection No. 99990001/98-006 open. Upon completion of further review of this event the NRC has determined that no further questions or concerns exist and therefore this inspection is closed.

Within the scope of this inspection, no violations were identified.
