Regarding your electronic mail (e-mail) dated August 29, 2001:

**Where do I find status of nuclear plants that were sent the Bulletin 2000-01?  
Is Diablo Canyon checking this cracking and if so, what is the status?  
Where do I find this information on the NRC website?**

The staff has not yet received the Diablo Canyon response to NRC Bulletin 2001-01, "Circumferential Cracking of Reactor Pressure Vessel Head Penetration Nozzles," dated August 3, 2001 (<http://www.nrc.gov/NRC/GENACT/GC/BL/2001/bl2001-001.html>), which gave all PWR licensees 30 days (until September 4, 2001) to provide the requested information about the status of their reactor vessel heads. The "Generic Activities on PWR Alloy-600 Weld Cracking Summary" web site (<http://www.nrc.gov/NRC/REACTOR/ALLOY-600/index.html>) contains all publically available information and provides links to other pages on the NRC's web site.

**Will this affect the recent relicensing received by Oconee?**

No, this issue will not affect the relicensing of any plant as this issue will be resolved in the current operating term.

**Have any other reactors today been discovered to have same cracking?**

The information provided in Bulletin 2001-01 provides the extent of the cracking known to date. As further information is made available to the staff, it will be made publically available.
