I, Daniel J. Turner declare as follows:

1. I am over the age of eighteen years of age and an attorney admitted to practice law before the Courts of the State of California. I am an associate in the law firm of McDermott, Will & Emery ("MWE"), working at the direction of the attorney named above the caption herein. MWE represents Morgan Stanley Capital Group Inc. ("MSCG") in the above-entitled matter. I have personal knowledge of the facts set forth below and, if called as a witness, I could and would testify competently thereto based upon such personal knowledge.

2. This supplemental declaration is submitted pursuant to the applicable provisions of the August 30, 2001 [Proposed] Order Re Disclosure of Documents by Market Participants to Key Personnel (the "Order"). Words or terms used herein that are either capitalized or in quotation marks are intended to be defined as set forth in the Order.

3. On August 15, 2001, MSCG identified William F. McCoy, Esq., Edward Zabrocki, Esq., Mary Lou Peters, Esq., Robert Kinney and Brian Armstrong as "Key Personnel" in accordance with the July 11, 2001 Order Directing Production of Documents to ISO/PX Market Participants Pursuant to Federal Bankruptcy Rule 2004 and Protective Order Respecting Confidentiality of Documents. See Declaration of Jonathan D. Twombly at pg. 3.

4. On August 24, 2001, the California Independent Systems Operator Corporation (the "ISO") filed its Opposition to Certain Applications for Disclosure ("Opposition"). In its Opposition and at the August 30, 2001, hearing before Judge Montali (the "Hearing"), the ISO objected to several of the Market Participants' applications for disclosure, including MSCG's.

5. At the Hearing, Norma G. Formanek, counsel for the ISO, stated that the ISO would withdraw its Opposition provided that none of the Key Personnel is involved in trading in the wholesale electricity markets, involved in competitive decision-making in those markets nor is involved in the competitive business of the ISO markets.

6. On September 5, 2001, I spoke to Edward Zabrocki, Esq., Vice Principal

and Counsel for MSCG. Mr. Zabrocki confirmed that none of the Key Personnel is involved in trading in wholesale electricity markets, involved in competitive decision-making in those markets nor is involved in the competitive business of the ISO markets.

7. On September 7, 2001, I confirmed the above in writing to Ms. Formanek. A true and correct copy of the September 7, 2001 letter from Daniel J. Turner to Ms. Formanek ("September 7 Letter") is attached hereto as Exhibit A.

8. On September 7, 2001, I spoke directly with Ms. Formanek regarding the contents of the September 7 Letter. Ms. Formanek stated that the September 7 Letter was sufficient for the ISO to withdraw its Opposition to MSCG's Key Personnel.

9. On September 10, 2001, I received a letter from Ms. Formanek confirming that the ISO was withdrawing its Opposition to MSCG's Key Personnel. A true and correct copy of the September 10, 2001 letter is attached hereto as Exhibit B.

I declare under penalty of perjury that the foregoing is true and correct. Executed this 10th day of September, 2001.

This will acknowledge my receipt of your letter dated September 7, which makes additional representations about the Key Personnel to whom Morgan Stanley Capital Group wishes to disclose Responsive Information produced by the California ISO in response to the Order Directing Production of Documents to ISO/PX Market Participants etc., filed July 11, 2001.

Based on the representations contained in your letter, the ISO withdraws its objections to such disclosure, except that the ISO continues to object to disclosure to Key Personnel for any Market Participant, including Morgan Stanley, of documents labeled CAISO 349-375.
