

The purpose of this modification is to exercise option year three of the contract in accordance with Federal Acquisition Regulation Clause 52.217-9, entitled, "Option to Extend the Term of the Contract," and Contract Clause C.10, entitled, "Duration of Contract Period," thereby extending the contract period of performance through September 29, 2002. As a result of this action, the ceiling amount of this contract is increased by \$20,562.50 from \$61,687.50 to \$82,250.00.

Accordingly, the contract is hereby modified as follows:

- (1) Under Subsection B.2 - CONSIDERATION AND OBLIGATION--DELIVERY ORDERS Paragraph a is deleted in its entirety and substituted in lieu thereof the following:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$82,250.00. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract."

- (2) Subsection C.10 - DURATION OF CONTRACT PERIOD is deleted in its entirety and substituted in lieu thereof the following:

"DURATION OF CONTRACT PERIOD (MAR 1987)  
ALTERNATE 4 (JUN 1988)

The ordering period for this contract shall commence on September 30, 1998, and will expire on September 29, 2002. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional one one-year periods."

A summary of obligations for this contract, from date of award through the date of this action is provided below:

There is no funding activity for this contract modification.
