

The purpose of this modification is to exercise option year four of the contract in accordance with Federal Acquisition Regulation Clause 52.217-9, entitled, "Option to Extend the term of the Contract," and Contract Clause F.3, entitled, "Duration of Contract Period." thereby extending the contract period of performance through September 7, 2002. As a result of this action, the ceiling amount of this contract is increased by \$56,628.34 from \$229,672.01 to \$286,300.35.

Accordingly, the contract is hereby modified as follows:

1. Under Subsection B.4 - CONSIDERATION AND OBLIGATION--DELIVERY ORDERS Paragraph a is deleted in its entirety and substituted in lieu thereof the following:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$286,300.35. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract."

2. Subsection F.3 - DURATION OF CONTRACT PERIOD is deleted in its entirety and substituted in lieu thereof the following:

"DURATION OF CONTRACT PERIOD (MAR 1987)
ALTERNATE 4 (JUN 1988)

The ordering period for this contract shall commence on September 8, 1997, and will expire on September 7, 2002. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) There are no option periods remaining under this contract."

3. By letter dated September 6, 2001, Babcock and Wilcox waives the requirement for a 60-day preliminary notice of the Government's intent to exercise the option period.
