SUBJECT: REVIEW OF ENVIRONMENTAL ASSESSMENT FOR ST. LUCIE
EXEMPTION BY STATE OF FLORIDA

The attached letter from the Florida Department of Community Affairs was received on September 10, 2001. It refers to an Exemption to allow Florida Power and Light to adjust the schedule of its St. Lucie Unit 2 Inservice Test interval to coincide with that of St. Lucie Unit 1, which was granted on June 12, 2001(TAC No. MB0615).

The letter indicates that the Environmental Assessment supporting the Exemption was reviewed by Florida state agencies and found to be consistent with the Florida Coastal Management Program. It also states that all future environmental documents prepared for this project must be forwarded to the Florida State Clearinghouse for inter-agency review.

On September 12, 2001, I called the Florida Department of Community Affairs and spoke to Mr. Danny Clayton, who had drafted the letter for the Chief of Staff. I acknowledged their finding and the request, but told him that this was a one-time exemption and I did not anticipate any future documentation on this project. He acknowledged this.

I asked him if we should add the State Clearinghouse to our service list for St. Lucie correspondence, in addition to our current state contact, Mr. William Passetti. He said this was not necessary, since the subject document apparently received the proper internal distribution.
