The staff estimates that the review will require approximately 220 review hours, and the target date for issuance of the SE will be May 31, 2002. The review hour estimate does not include time required to coordinate the review and develop and issue the SE. To enable the staff to complete the review on the schedule requested by the WOG, close and frequent communications between our technical staffs will be required.
