Dear Sir or Madam:

Pursuant to the provisions of the Freedom of Information Act, as amended, 5 U.S.C.A. § 552, and related regulations issued by the United States Nuclear Regulatory Commission ("NRC") in 10 CFR Part 9, we are requesting all documents relating to any involvement between the NRC or its predecessor, the AEC, and the former Westinghouse Electric Company's Cheswick facility which is currently owned by the Washington Group. The relevant timeframe would be from 1957 to 1972. We are particularly interested in documents relating to work performed under both the AEC Contract # AT-11-1-GEN-14 (navy fuel fabrication), and any subsequent modifications thereof, and the NERVA project (astronuclear fuel fabrication). Further, we would like to review any documents that would identify government personnel working on site and the nature of their duties there.

As used in this request, the term "document" or "record" includes but is not limited to all communications, reports, correspondence, memoranda, telephone conversations, summaries or records of personal telephone conversations, interviews, diaries, notebooks, summaries of records of meetings or conferences, summaries or reports of meetings or conferences, summaries or reports of consultants, drafts, letters, any marginal comments appearing on any document, and all other writings.

We agree to pay appropriate costs in connection with photocopying. However, if the costs of copying will exceed \$100, please notify me before proceeding. If portions of any requested documents or records are exempt from disclosure under Section 552(b) of the Freedom of Information Act, we request that all non-exempt reasonably segregable portions of such documents be made available. We also request, pursuant to 40 CFR Section 2.113(d), that EPA identify any documents or portions thereof that EPA deems to be exempt from disclosure and explain the basis for the non-disclosure or the alleged exemption from disclosure of any such documents or portions thereof.

We appreciate your prompt attention to this request. Thank you.
