Dear Mr. Hinnant:

This refers to our letter of April 5, 2001, in which we forwarded to you the results of the NRC's Office of Investigations (OI) Case No. 2-2000-027. This investigation involved the allegation that a former corporate Security Project Support Analyst had been discriminated against by Carolina Power and Light Company (CPL) because he had engaged in protected activity. OI concluded that there was not sufficient evidence developed during the investigation to substantiate discrimination. The synopsis to the OI report was enclosed with that letter.

At the time, the individual alleging discrimination also had a case pending before the DOL Occupational Safety and Health Administration (OSHA), and we advised CPL that the NRC would withhold its judgement on the matter pending a decision by DOL. On June 28, 2001, we received information from DOL indicating that OSHA did not verify that discrimination was a factor in the actions comprising the complaint.

Given the DOL and OI investigation conclusions, and the fact that the individual has not appealed the OSHA decision, the NRC plans no further action regarding this case. If you should have any questions regarding this letter, please feel free to contact me at 404-562-4421.
