Pursuant to 10 CFR 72.212, "Conditions of general license issued under 10 CFR 72.210," paragraph (b)(1)(ii), we are registering with the NRC the use of a cask under the general license to store spent fuel at Dresden Nuclear Power Station, Units 1 and 2. The initial use of the cask to store spent fuel occurred on September 18, 2001. This registration is required to be submitted within 30 days. Accordingly, this submittal is due by October 18, 2001.


