

On August 22, 2001, NRC issued Regulatory Issue Summary (RIS) 2001-17, *Preparation and Scheduling of Operator Licensing Examinations*. RIS 2001-17 requested licensees to submit, on a voluntary basis, information pertaining to their proposed site-specific operator licensing examination schedule and the estimated number of applicants planning to take those examinations as well as the NRC generic fundamentals examinations (GFE). The NRC stated that this information would help the NRC plan the use of its resources. A response was requested within 30 days of receipt of RIS 2001-17.
