**VOGTLE ELECTRIC GENERATING PLANT**  
**PHYSICAL SECURITY AND CONTINGENCY PLAN REVISION**

In accordance with 10 CFR 50.54 (p) and 10 CFR 50.4, Southern Nuclear Operating Company hereby submits three copies of a revision to the Vogtle Electric Generating Plant (VEGP) Unit 1 and Unit 2 Physical Security and Contingency Plan. By copy of this letter, two copies of the revision are being provided to the NRC Region II office.

This revision includes changes to: 1) the definition of "Isolation Zone" in the GLOSSARY section; 2) Section 3.1 to add an additional non-security activity; 3) Section 3.1.1 and 6.7 to eliminate a specific Vital Area patrol frequency; 4) issue the latest drawing of Figures 4-1, 4-5, and 4-6; 5) Table 4-1 to reconfigure existing Vital Areas; and 6) Section 5.4.2.3 to provide additional guidance regarding search of a vehicle returning from the Owner Controlled Area. In addition, Figures 1-1, 4-2, 4-3, 4-4, and 5-1 are being re-issued with better quality drawings.

Enclosure 1 provides the description and justification for the changes, and Enclosure 2 contains the actual revised pages. Enclosures 3 and 4 give insertion instructions and the new effective page list for the VEGP Physical Security and Contingency Plan. Only Enclosure 2 is safeguards information and should be withheld from public disclosure in accordance with 10 CFR 73.21.


