I would like to personally invite you to attend this Annual Assessment Meeting. Also in conjunction with this meeting, I would like to invite you to a separate meeting between you and other State and local government officials, and my staff. This meeting will be conducted in Room 227 at the same location shortly after the conclusion of the Annual Assessment Meeting. The purposes of this meeting are to meet the NRC inspectors at St. Lucie, and to ensure that you are aware of the NRC inspection and assessment process and the avenues that are available to bring concerns that you or your constituents have to the NRC. This meeting will also provide you the opportunity to inform us of any current personal or constituent concerns with St. Lucie. There is also another means for you to become familiar with the Reactor Oversight Process and the specific performance of St. Lucie.
