We have reviewed the final Alabama regulations for Control of Radiation, Chapter 420-3-26, which became effective on August 6, 2001. The regulations were sent on July 27, 2001. The final regulations are in response to the one amendment identified in the enclosed State Regulation Status (SRS) Data Sheet. The regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Part 30.10, Deliberate misconduct. In addition, we reviewed our May 23, 2001 letter to you that addressed the proposed regulations. We also discussed our review of the regulations with you on August 7, 2001.

The Alabama deliberate misconduct rule is compatible, as adopted and meets the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200, provided that the unlicensed person who is the direct or indirect subject of the enforcement action taken in accordance with Alabama Rule 420-3-26-.01 is afforded the opportunity to appeal the enforcement action to the State.

We have also summarized on the SRS Data Sheet our knowledge of the status of other Alabama regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the SRS Data Sheet.
