NRC STAFF SUPPLEMENTAL RESPONSE TO TENNESSEE VALLEY AUTHORITY'S FIRST REQUEST FOR PRODUCTION OF DOCUMENTS

I. <u>INTRODUCTION</u>

The Nuclear Regulatory Commission (NRC) Staff (Staff) hereby provides this supplemental response to Tennessee Valley Authority's (TVA) First Request for Production of Documents, filed August 3, 2001.
