SUBJECT: TRITIUM IN SEWAGE FROM A DEPARTMENT OF ENERGY FACILITY

The Columbia Generating Station, under contract with the Department of Energy (DOE), processes the sewage from area 400 of the Hanford Reservation. The sewage contains tritium below the State of Washington's guidelines for safe drinking water. The tritium is in the aquifer from which the DOE facility obtains its drinking water. The tritium comes from past DOE activities on the Hanford Reservation. The personnel at the DOE facility use the water for sanitary purposes and then sends the sewage to the Columbia Generating Station sewage treatment plant. The sewage containing the tritium is then processed by the sewage treatment plant, the sewage is removed and the water containing the tritium is returned to the same aquifer from which it came.

The State of Washington Department of Health which regulates the sewage treatment plant questioned if this was regulated under the 10 CFR Part 50 license for the Columbia Generating Station. The NRC's position is since the tritium in the sewage is not produced by an NRC regulated facility (the tritium is from DOE activities) it is not covered by Energy Northwest's Part 50 license (the Final Safety Analysis Report states that the State of Washington regulates the sewage facility). Therefore, since Washington is an agreement state and it already regulates the sewage, the State of Washington should regulate the tritium, not the NRC. This was communicated to the State of Washington (see attached e-mails).
