In accordance with 10CFR50.71(e) and 10CFR50.4(b)(6), enclosed is a copy of Amendment 17 of the Arkansas Nuclear One, Unit 1 (ANO-1) Safety Analysis Report (SAR). Included with this update is a copy of the current Unit 1 Technical Requirements Manual and a copy of Revision 7 of the Fire Hazards Analysis (FHA) for ANO, Units 1 and 2. The enclosed documents are provided on CD-ROM. Pursuant to 10CFR50.71(e)(4), these documents are being submitted within six months following the previous ANO-1 refueling outage (1R16) which ended April 8, 2001.

A summary of the 10CFR50.59 evaluations associated with Amendment 17 of the ANO-1 SAR and Revision 7 of the FHA will be provided under a separate cover letter within 30 days as part of the ANO-1 10CFR50.59 Report.

As required by 10CFR50.71(e)(2), I hereby certify that to the best of my knowledge and belief, the information contained in Amendment 17 of the ANO-1 SAR and Revision 7 of the FHA accurately reflects changes made since the previous submittal. The changes to these documents reflect information and analyses submitted to the Commission, prepared pursuant to Commission requirements, or made under the provisions of 10CFR50.59.
