SUBJECT: SURRY UNITS 1 AND 2 - CORRECTION TO AMENDMENT NOS. 147
AND 143 (TAC NOS. 67386, 67387, 71555 AND 71556)

On October 24, 1990, the Commission issued Amendment Nos. 147 and 143 for the Surry Power Station, Units 1 and 2. The amendments revised the heatup and cooldown curves to be effective from 11 effective full power years (EFPY) of operation to 15 EFPY.
