> RE: RESOLUTION OF THE HYDRAULIC EQUIVALENCY ISSUE ASSOCIATED WITH LASER WELDED SLEEVING REPAIR OF STEAM

GENERATOR TUBES (TAC NOS. MB1052 AND MB1053)

Dear Mr. Terry:

By letter dated September 6, 2000, TXU Electric, the licensee for the CPSES, requested an amendment to its operating licenses to allow installation of laser-welded tube sleeves as an alternative to plugging defective steam generator tubes for CPSES, Unit 1, as supplemented by letter dated December 14, 2000. By supplemental letter dated January 25, 2001, the licensee modified its request to include a clearly conservative hydraulic equivalency of sleeved to plugged tubes. The U.S. Nuclear Regulatory Commission (NRC) issued Amendment Nos. 83 and 83 for CPSES, Units 1 and 2, respectively, by letter dated February 20, 2001, approving the modified request with an understanding that the NRC staff would continue to review the hydraulic equivalency values proposed in the original request. The NRC staff has completed that review as documented in the enclosed Safety Evaluation (SE).

The NRC staff has determined the hydraulic equivalency values, as originally proposed, to be acceptable for the 30- and 36-inch sleeves because they have been supported by test data, and there is sufficient conservatism remaining to compensate for analysis assumptions that have not been fully justified. Hydraulic equivalency values for sleeves of less than 30 inches in length are acceptable with the stipulation that such sleeves shall be assumed to be at least 30 inches long. A "best estimate basis" has not been sufficiently supported and would require additional clarification and validation to be acceptable. Thus, the hydraulic equivalency values for the 36-inch hot leg, 30-inch hot leg, and 30-inch hot leg and cold leg are acceptable; these values are also acceptable for sleeves shorter than 30 inches.

The enclosed SE is being forwarded to TXU Electric, at this time, to request the licensee's assistance in the identification of any proprietary information, in the SE, which should be withheld from public disclosure per Title 10, Code of Federal Regulations, Part 2, Section 2.790. During an October 3, 2001, telephone conversation with Mr. D. Bushbaum of TXU Electric,
