The purpose of this modification is to revise Section B.3 CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988) ALTERNATE I, by: (1) authorizing additional monies to fund final indirect rate increases, for this contract closeout effort thereby fully funding the contract; and (2) increase funding by \$3,571.51 from \$1,980,500.71 to \$1,984,072.22.

Accordingly, the contract is modified as follows:

Under Subsection B.3 CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988) ALTERNATE I, paragraphs (a) and (C) are deleted entirely and the following is substituted in-lieu thereof:

"(a) The total estimated cost to the Government for full performance of this contract is \$1,984,072.22, of which the sum of \$1,867,782.22 represents the estimated reimbursable costs, and of which \$116,290.00 represents the fixed fee.

(b) The amount presently obligated with respect to this contract is \$1,984,072.22."
