

The purpose of this modification is to provide incremental funding in the amount of \$1,000, thereby increasing the obligated amount from \$27,938 to \$28,938. In addition, this modification corrects an administrative error made at the time of award in the Price Schedule included in Section B of the contract. Accordingly, the following change is hereby made:

1. In Part I, the Schedule, Section B - Supplies or Services and Price/Costs, for the item entitled "OPTION YEAR (2nd -Year), the unit price for Consulting Services should have been \$90.00 per hour and not the \$105.00 inadvertently listed. A Unit Price of \$90.00 per hour was proposed for both the base year and the option year of this contract. The amount for the Consulting Services equal to \$8,100 is correct, as the Estimated Quantity of hours was 90 and the Unit Price should have been \$90.00, which does equal the \$8,100 listed.
2. Section B.3, CONSIDERATION AND OBLIGATION TIME AND MATERIALS/LABOR HOUR CONTRACT, paragraph (c) is hereby deleted in its entirety and replaced with the following:

"(c) The amount presently obligated by the Government with respect to this contract is \$28,938."

A summary of obligations for this contract, from award through the date of this action, is provided below:

This modification obligates FY01 funds in the amount of \$1,000.

All other terms and conditions, **including the ceiling of \$31,998**, remain unchanged.
