SUBJECT: MODIFICATION NO. 4 TO INTERAGENCY AGREEMENT NO. NRC-10-00-006,
ENTITLED "SOFTWARE MAINTENANCE AND DEVELOPMENT SERVICES"

Dear Mr. James:

The purpose of Modification No. 4 is to (1) extend the period of performance of this Interagency Agreement for an additional 12 months, from 10/01/2001 to 9/30/2002; (2) incorporate the total amount for the extended 12 month period; and (3) obligate FY 2001 funds in the amount of \$30,000.00. Accordingly, the contract is hereby modified as follows:

1. Article II - "Period of Performance," the paragraph under this article is DELETED in its entirety and the following paragraph is SUBSTITUTED in lieu thereof:

The period of performance for this Agreement shall commence on October 1, 1999 and expire on September 30, 2002. Any such changes to the period of performance shall be incorporated into this Agreement by the issuance of modifications to this Agreement.

2. Article III - "Payment by NRC to DOCBOC," paragraph 3, which cites funding data, is DELETED in its entirety and the following funding data is SUBSTITUTED in lieu thereof:

3. Article IV - "Obligation of Funds and Estimated Amount," the two paragraphs under this article are DELETED in its entirety and the following paragraphs are SUBSTITUTED in lieu thereof:

The total estimated amount of this Agreement for the extended 12 month period of performance; October 1, 2001 through September 30, 2002 is \$230,142.00. The amount presently obligated by the NRC for this extension is \$30,000.00.

It is estimated that the amount currently obligated will cover performance through November 15, 2001.
