
Gentlemen:

The purpose of this letter is to inform the Nuclear Regulatory Commission (NRC) that effective Friday, October 12, 2001, David L. Wilson will become the Vice-President of Nuclear Energy at Cooper Nuclear Station (CNS) for the Nebraska Public Power District (District). Although Mr. Wilson also is an employee of the Nuclear Management Corporation (NMC) as the NMC Vice-President of Operations Support, his activities at CNS, through a contract between NMC and the District, are being performed at the pleasure of, and at the direction of, the District's Senior Vice President. In this regard, the Senior Vice President has granted Mr. Wilson the authority to represent the District on matters before the NRC and may sign CNS-related documents under oath and affirmation. This approach is consistent with regulatory requirements of 10 CFR 50.80 and does not trigger a review pursuant to NRC Regulatory Issue Summary 2001-006, "Criteria for Triggering Review Under 10 CFR 50.80 for Non-Owner Operator Service Companies." The District clearly retains the authority and responsibility for the safe operation of the plant and for regulatory compliance.

Accordingly, please update the mailing address for CNS NRC correspondence by replacing Mr. John H. Swailes with Mr. David L. Wilson.
