PROPOSED CHANGE TO THE ENTERGY QUALITY ASSURANCE PROGRAM MANUAL

I. Current Requirement

QAPM Table 1, Section C.9 lists a specific Clarification/Exception to ANSI N18.7 Section 4.3.4, "Subjects Requiring Independent Review." Section C.9 states:

"Examples of the matters reviewed by the on-site safety review committee in accordance with this section are the following:

- a. new and revised station administrative procedures and
- b. changes to the Emergency Plan (except editorial changes)."

II. Proposed Change

Entergy Operations, Inc. proposes to delete Clarification/Exception Section C.9.a of QAPM Table 1, thereby allowing the onsite review committee the flexibility to determine which procedures the committee should review based on the procedure's importance and impact to nuclear safety.

III. Justification of Proposed Change

ANSI N18.7, Section 4.3.4 provides a specific requirement for the independent review of proposed changes in procedures that involve changes in technical specifications or an unreviewed safety question. Section 4.3.4(5) provides for the review of any other matter involving safe operation of the nuclear power plant, which an independent reviewer deems appropriate for consideration.

The requirements in Section 4.3.4 are appropriate as written for determining which procedures need on-site safety review committee review and are not enhanced by having an additional requirement for the review of a specific type of procedure (as Section C.9.a requires). In other words, deleting the Clarification/Exception allows the onsite safety review committee to make procedure review determinations based upon the procedure's importance and nuclear safety impact rather than just having the procedure's classification as "administrative."

10.	ANSI N18.7 Section 4.5	This section establishes minimum 2 year audit frequency for all safety related functions. Entergy will perform audits at frequencies as discussed in QAPM Section C.2.a instead of this section.
11.	ANSI N18.7 Section 4.5	The independent review body discussed in this section is the off-site safety review committee.
12.	ANSI N18.7 Section 5.1	Instead of the requirements of this section to have a summary document, a method of cross referencing these requirements to the implementing procedures will be maintained.
13.	ANSI N18.7 Section 5.2.2	The person who holds a senior reactor operators license for the affected unit and approves a temporary change to a procedure is not required to be in charge of the shift.
