This memo documents that Westinghouse Electric Company (W) submitted a request to withhold from public disclosure information to be presented at a meeting to be held with the NRC staff on October 29, 2001. The request was made by letter and affidavit dated October 18, 2001.

W requested that the meeting be closed based on their intent to discuss proprietary information related to W's strategy for development of next-generation fuel. The NRC staff has reviewed the information provided and concurs that its release would improve a competitor's competitive position and therefore should be protected as proprietary. W has agreed to provide a non-proprietary overview of the subject of the meeting during an introductory part of the meeting, which will be open to the public. A nonproprietary version of presentation materials will be made available at the meeting for release to the public.

This memo to file is being developed to allow documentation of the staff's review of the material prior to the meeting. Formal response to the submittal and affidavit will be developed in parallel with development of this memo.
