Plans have now been completed for the visit of ten Senior Regulators from East Europe, Russia, and Ukraine to study NRC's revised Reactor Oversight Process (ROP). The regulators will be briefed by NRR and RES management and staff on details of the ROP, as well as with complementary information on risk-informed decision-making at NRC during November 5-7, 2001. The regulators will then travel to Region III for briefings on November 8 concerning the Region's perspective on the ROP. On November 9, the regulators will split into two groups and visit either D.C. Cook or Palisades for detailed discussions of experience and implementation of the ROP with utility management and staff at corporate headquarters just offsite of the two facilities.
