This memo documents that, in accordance with guidance in the Project Manager's Handbook, Michael Scott, the previous Project Manager for SONGS, has incorporated the most recent revision to the SONGS Units 2 and 3 Updated Final Safety Analysis Report (UFSAR) (Revision 16 dated 8/02/01) into my copy of the UFSAR.

In addition, Michael Scott has performed a sampling review of licensing actions completed during the period of time covered by the licensee's UFSAR revision to verify whether completed actions that should have resulted in a revision to the UFSAR were in this revision. He reviewed five licensing action packages. He concluded that three of the five did not appear to affect information in the UFSAR. The other two packages affected UFSAR content, and they both appeared to be appropriately incorporated into the licensee's UFSAR revision. Due to his short tenure as San Onofre Project Manager (less than two months), he was unable to review any packages with which he was familiar and he concluded that this potentially limited the usefulness of his review.
