Brief description of amendments: The amendments revise Technical  
Specification 3.6.5.5 to allow a pressurizer enclosure hatch between the  
upper and lower containment volumes to be open for up to 6 hours, instead  
of 1 hour, to facilitate inspections of components such as PORV block  
valves.
