FOIA REQUEST

Under the provisions of the Freedom of Information Act and relevant agency regulations, I hereby request a copy of the following information in the possession, custody, or control of the Nuclear Regulatory Commission ("NRC") relating to the Starmet Corporation (former Nuclear Metals, Inc.) site in Concord, Massachusetts (the "Site):


- (1) All records referring or relating to contractual or other agreements between the Atomic Energy Commission ("AEC") and Starmet Corporation, Nuclear Metals, Inc., or affiliated entities, for the purchase of goods or services or otherwise, including without limitation, Contract At (30-1)-1565 which the AEC and Nuclear Metals, Inc. ("NMI") entered into on or about July 1, 1954, and all subsequent modifications thereto;
- (2) All records referring or relating to inspections, investigations, or other review of Site operations or conditions by the AEC or the NRC, from 1950 to date;
- (3) All records referring or relating to the actual or potential responsibility of any party, including without limitation, the AEC or the NRC, for the environmental cleanup or remediation of the Site or for the reimbursement of costs associated therewith;
- (4) All records referring or relating to any AEC policy of general effect, from 1950 to date, to indemnify or hold harmless contractors for the purchase of goods or services against losses, expenses, or other damages arising out of, based on, or caused by the explosive, radioactive, or other hazardous properties of source material, special nuclear material, or byproduct material, as said materials are defined in the Atomic Energy Act of 1954, or otherwise to indemnify or hold harmless such contractors;

- (5) All records referring or relating to any AEC policy of general effect, from 1950 to date, as to its sharing of costs or its sharing of ownership or operational responsibilities with contractors for the purchase of goods or services, including without limitation, any AEC policy or guidance relating to:
- (a) its financing of the construction of facilities operated by contractors;
 - (b) its ownership or lease of real property operated by contractors;
 - (c) its ownership or lease of equipment utilized by contractors;
 - (d) its ownership of raw materials utilized by contractors;
 - (e) its ownership of byproducts or wastes generated by contractors;
 - (f) its responsibility for the disposal or other disposition of byproducts or wastes generated by contractors;
 - (g) its supervision of contractors' operations;
 - (h) any other AEC involvement or participation in contractors' operations;

I understand that as a commercial requestor I may be required to pay reasonable FOIA processing fees. However, please notify me for fee authorization if these fees exceed \$55.00. Thank you for your assistance in this matter.
