They requested reciprocity to perform activities out of the Indianapolis, Indiana branch office at two (2) locations in the Commonwealth, one in Paducah and one in Elizabethtown, using radioactive materials as contained in a Troxler moisture/density gauge. The fax noted that the activities were to begin "now". Kevin Kessley, Branch Manager of the Indianapolis, Indiana office of Professional Service Industries, Inc., was contacted by telephone (317-216-7131) and informed that Professional Service Industries, Inc. in Indiana has no active reciprocity license with the Commonwealth at this time. Mr. Kessley was forthcoming in stating that Professional Service Industries, Inc. of Indiana was already in Paducah doing moisture/density work and had been for a week. Mr. Kessley stated that he assumed that the corporate office had established reciprocity with the Commonwealth to authorize Professional Service Industries, Inc. of Indiana to bring radioactive materials into the commonwealth.

Mr. Kessley was informed that (1) an active reciprocity license must be on file for Indiana, and (2) a seventy-two (72) hour notice is required before entering the Commonwealth of Kentucky. The Commonwealth of Kentucky ordered Professional Service Industries, Inc. of Indiana to leave Kentucky. The Cabinet for Public Health will consider issuing reciprocity to this contractor only after reviewing the actions taken by Region III.

The Cabinet for Public Health will consider issuing reciprocity to this contractor only after reviewing the actions taken by Region III.
