Ladies and Gentlemen:

On February 1, 2001, Constellation Nuclear, LLC (on behalf of its indirect subsidiary Nine Mile Point Nuclear Station, LLC ("NMP LLC"), Niagara Mohawk Power Corporation, New York State Electric & Gas Corporation, Rochester Gas and Electric Corporation, and Central Hudson Gas & Electric Corporation, filed an application for an order and conforming administrative amendments for the transfer of the NRC facility operating licenses for Nine Mile Point, Units 1 and 2. The application was granted by the Commission by Order dated June 22, 2001, supplemented by Supplemental Order dated October 30, 2001.

The purpose of this letter is to provide additional information relating to the application.

1. On page 15 of the application, it is indicated that an additional officer of NMP LLC will be designated. The name of that officer is Raymond L. Wenderlich. Mr. Wenderlich is a citizen of the United States.
2. On page 17 of the application, it is indicated that the onsite executive officer team for Nine Mile Point, Units 1 and 2 will report to a senior executive of NMP LLC, who will also serve as a senior executive of Constellation Nuclear, LLC. The senior executive of NMP LLC is Raymond L. Wenderlich, Senior Constellation Nuclear Officer Responsible for Nine Mile Point, P.O. Box 63, Lycoming, NY 13093-0063, at (315) 349-4049.


