REVIEW AND CONCURRENCE: LIST OF APPROVED SPENT FUEL SUBJECT:

STORAGE CASKS: STANDARDIZED ADVANCED NUHOMS®-24PT1

Your concurrence is requested on the attached proposed rule.

The Nuclear Regulatory Commission (NRC) is proposing to amend its regulations by adding the Standardized Advanced NUHOMS®-24PT1 cask system to the "List of Approved Spent Fuel Storage Casks." The Standardized Advanced NUHOMS® -24PT1 design has improved shielding and the ability to withstand a higher seismic response spectra than the Standardized NUHOMS® -24PT1 Storage System; otherwise, the cask designs are the same.
