NRC STAFF'S RESPONSE TO ATOMIC SAFETY AND LICENSING BOARD'S ORDER
REGARDING PRODUCTION OF DOCUMENTS

INTRODUCTION

The Staff hereby files its response to the order issued by the Licensing Board in a conference call on November 7, 2001.

DISCUSSION

On November 7, 2001, the Licensing Board presiding over this proceeding ordered the staff to justify its withholding of "daily event reports" related to the Catawba and McGuire plants that were previously available through the NRC website. Specifically, the Licensing Board ordered that: (1) the staff consider producing the documents to the petitioners (if necessary, using a protective order); (2) if the staff refuses to produce the documents, explain the legal basis for withholding them; and (3) the staff should consider whether the documents would ever be publicly available.

The NRC Staff has reviewed the daily event reports related to the Catawba and McGuire plants and has concluded that it is able to make them available to the petitioners and the applicant in the instant proceeding. The Staff today will send through overnight mail the reports that were previously available on the NRC website through October 31, 2001. Any

reports generated subsequent to October 31, 2001 will be sent through overnight mail on a weekly basis to the petitioners and the applicant in this proceeding. This procedure, however, will cease upon termination of the proceeding or when the agency makes a determination on the public availability of these documents.¹

The NRC Staff is making these documents available as a courtesy to help expedite the current proceeding. However, the Staff maintains that it is under no obligation to make these documents available prior to discovery. Therefore, the Staff action should not be construed as a waiver of any rights or objections to the production of these documents or other documents similarly unavailable.
